

Privacy Policy

Following the entry into force, on 25 May 2018, of Regulation (EU) of the European Parliament and of the Council No 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as GDPR, we would like to kindly inform that:

1. The personal data administrator (controller) shall be OPEGIEKA Sp. z o.o. with its registered office at al. Tysiąclecia 11, 82-300 Elbląg.

2. Mr Tomasz Wechterowicz shall act as Data Protection Supervisor; e-mail address: iod@opegieka.pl.

3. Your disclosed personal data shall be processed for the purposes of:
direct marketing (a reply to the notification sent by means of the contact form)
and

sending marketing materials and commercial information in the future (in the event that you have given relevant consent in this respect).

4. The legal basis for processing your personal data by OPEGIEKA Sp. z o.o. shall be Regulation (EU) of the European Parliament and of the Council No 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), and in particular Art. 6, par. 1, letter f) pursuant to which processing is necessary for the purposes of the legitimate interests pursued by the controller in order to reply to the request for quotation; and Art. 6, par. 1, letter a) pursuant to which the data subject has given consent for processing of their personal data for marketing purposes.

5. The personal data which has been made available by you shall not be subject to being made available any further.

6. Your personal data shall be processed until a notification of objection to further processing has been filed or the consent in question has been withdrawn, both of which may be submitted electronically by sending an e-mail to the following address: iod@opegieka.pl

7. You shall have the right to access your data and the right to rectify your data in the event that such data is inconsistent with the actual status, as well as the right to request deletion or restriction of processing thereof. In the cases stipulated under the provisions of law, subject to the requirement that such law may not adversely affect the rights and freedoms of other persons, including trade secrets and intellectual property, you shall have the right to transfer personal data (data portability) to the extent technically feasible or the right to obtain a copy of personal data.

You shall also have the right to file an objection to further processing of your personal data, which would have the effect of deleting your personal from the customer base.

Should the data subject deem that processing of their personal data is in breach of the provision of General Data Protection Regulation of 27 April 2016, the data subject shall have the right to complain to the data protection supervisory authority, i.e. the President of the Personal Data Protection Office.

8. The data processed by Opegieka Sp. z o.o. shall not be sent or transferred to third countries.

9. The personal data which has been made available by you shall not be subject to profiling.
